

Private Sector Dialogue: Jointly Achieving Universal Health Coverage

Kenya Healthcare Federation led the UHC dialogue where over 40 healthcare financing champions stepped away from their normal schedule to take part in an important topic, "Healthcare Financing and Universal Health Coverage", on the 23rd of March 2016 at Sankara Hotel Nairobi.



Dr. Omar H. (Pictured) of Ministry of Health Kenya gave the opening remarks where he outlined the success of the recent Healthcare financing tour to Japan by Kenya organized by JICA.

Chairman Kenya Healthcare Federation, coordinated roundtable discussions which are to be documented as the views of the private sector as an input for the Kenya Health Financing Strategy. Some of the major Healthcare champions who attended were, Mr. Daniel Mulinge of NHIF, Mr. Isaac Nzyoka' of UAP Insurance, Dr Njeri Mwaura and Jane Chuma of World Bank Group and Ron Ashkin of PSP4H.

KHF's Healthcare financing committee chaired by Isaac Nzyoka' of UAP Insurance will continuously engage with the government in healthcare financing policy formulation meetings and specifically the Kenya Health Financing Strategy to voice support and concerns and provide alternative solutions from the private sector to issues facing the healthcare financing. Financial Sector Deepening (FSD) led by Mr. Paul Gubbins and Ms. Tamara Cook sponsored the event and presented the comprehensive Financial diaries report, "struggling to thrive"

PROJECTS

1. Afya Elimu Fund

Since 2012, KHF is a key partner of the IntraHealth International FUNZOKenya project with the goal of increasing the number, quality and geographical spread of health workers in Kenya. One of the main pillars of the FUNZOKenya project is the Afya Elimu Fund (AEF), a vision 2030 flagship project. The AEF is a loan mechanism where students can annually apply for part of their tuition fees and is administered by the Higher Education Loans Board (HELB). The AEF targets to raise Ksh. 1.5 Billion to put in the revolving fund to support 12,000 needy students in five years.

For the year 2016 the target is set to support at least 600 students. The average annual cost per student is estimated at Ksh. 50,000/=. To this end KHF has committed to assist the AEF in raising at least Kshs.30million from the private sector partners and would like to request its members to pledge funding for the AEF. In mid-July there will be a high-level event graced by the First Lady and the CS of Health Kenya to re-launch the AEF and acknowledge the contributors to the fund.

2. Private sector health partnership Kenya (PSHP)

Together with partner UNFPA, KHF forms the secretariat of the recently established Private Sector Health Partnership – Kenya (PSHP-Kenya). Currently the PSHP Kenva collaboration is signed between the National Government Ministry of Health and County Governments of Wajir, Isiolo, Lamu, Mandera, Migori and Marsabit, and private sector companies Safaricom, Philips, MSD, Huawei and GSK with the aim of welcoming more private sector champions once the governance structure is in place.

Through its collective action partners the partnership will help build models that offer the best of both public and private sector, with the potential for scaling-up the delivery of healthcare for vulnerable and poor populations in low-resource settings. By the end of April the PSHP-Kenya website will go live and will be shared with all.

3. Market Study on the Kenyan Healthcare Sector.

KHF, in partnership with the Dutch Taskforce HealthCare, was recently awarded the contract from the Embassy of the Kingdom of the Netherlands to undertake a study in Kenya on the healthcare services and infrastructure sector.

The aim of the project is to provide the Dutch Embassy insights in the current status of the health sector in Kenya and to set out recommendations for opportunities of engagement. KHF continues to engage with partners in the health space to explore possibilities of engagement.
